

# COUNCIL MEETING Wednesday, September 6, 2017 103 Water St. Elephant Butte, NM 87935 ACTION MINUTES

#### CALL TO ORDER AND PLEDGE OF ALLEGIANCE

The Mayor and Mayor pro Tem being absent in the presence of a quorum, Councilor Rogers called the Meeting to order at 2:00pm, and Councilor Trager led the Pledge of Allegiance.

#### **ROLL CALL**

Clerk Rieth called the roll.

Councilor Lafont, Councilor Rogers, and Councilor Trager were all present.

Mayor Pro Tem Skinner was absent but arrived late.

Mayor Kent was absent, but joined for Executive Session.

Clerk Rieth declared a quorum was present.

## **PUBLIC COMMENT**

Jerry Ballard, T or C, NM Lease lots explained that the Airforce wants to do their training exercises over Elephant butte. Mr. Ballard is trying to get a Blue Sky Ordinance passed by T or C, City of Elephant Butte and 'Villiamsburg, and announced there will be a meeting at the Civic Center on September 19<sup>th</sup>. Mr. Ballard urges Sity of Elephant Butte to participate. Mr. Ballard offered to provide copies of a draft Ordinance in effect in Hawaii.

Ed Mike Burke, 208 Calle del Sol, Elephant Butte, stated concern about the condition of lots and houses in the city including 110 Calle del Sol which is an empty lot, 205 Calle del Sol which complaints have been made for the last year and a half about the property being in disrepair, and also 214 Calle del Sol.

#### **IANAGER'S REPORT**

Manager Lucero reported having Space men, Rockets, and Elephants to throw out in the Parade. This year there will be a new Parade Route. There are still Raffle Tickets and T-shirts available.

## FIRE CHIEF AND CODE ENFORCEMENT REPORT

Chief Boone reported E-Days Parade Route has changed. Butte Blvd will be closed during the parade. Traffic will be re-routed through Hallmark and County Club. The city will be hosting the 9/11 Memorial at 8am on Monday, September 11, 2017. The radio tower is scheduled to be completed on Thursday, September 7, 2017. Chief Boone stated that since January 1, 2017 there has been a total of 81 calls and complaints, 51 animals at large, and 37 Zoning permits. A report from the State Police should be available at the next Council Meeting.

A Roll Call Vote was held: Councilor Trager voted yes. Councilor Rogers voted yes Councilor Lafont voted yes. Mayor Pro Tem Skinner voted yes. Motion carried.

Clerk Rieth stated that the bid opening for the Wastewater Treatment Plant Improvements, project #17-18-002 was held August 17, 2017 at 2pm. There were a total of four bidders. The bid from C&E Industrial Services, nc. contained mathematical errors which had no impact to the bid results. A summary of the 3 lowest bids are included on page 8 of Council packets. The apparent low bidder's licenses have been verified with NM licensing services, are valid for the type of work to be accomplished, and are in active status. Funding Analysis by Bohannan Huston can be found on page 11 of Council's Packets. The City currently does not have adequate grant funding available to award all bid lots at this time. It is therefore recommended by our Engineers, with concurrence from Director Cole that Council award bid lots 1-3 only to Smithco Construction. Page 12 of Council packets is a letter of Concurrence from NMED. Any shortfalls indicated in the funding analysis will be covered by the General Fund. Clerk Rieth introduced Mr. Dave Shields from Bohannan Huston to answer questions.

Mr. Shields addressed questions and concerns from Council.

Councilor Rogers made a motion to approve award of 17-18-002 Wastewater Treatment Plant Improvement Lots 1-3 to Smithco Construction.

Councilor Lafont seconded.

A Roll Call Vote was held:
Councilor Trager voted yes.
Councilor Rogers voted yes
Councilor Lafont voted yes.
Mayor Pro Tem Skinner voted yes.
Motion carried.
