Cook-Off Rules

General Rules:

- Entry Fee \$150. Mandatory Chef meeting Friday, Sept. 9 at 4pm. At City Hall, 103 Water Street.
- The City will provide Pork Baby back ribs. Contestants must provide 2 sides—ie: corn, beans, coleslaw, dessert, etc.
- The contestant or team may cook as many as they wish (up to 16 racks), but only ONE rack and one side may be presented for judging. One rack will be set aside for the rib eating contest. The remaining ribs will be exchanged by public: One coupon for one rib, or one side. All Department of Health guidelines for food vendors must be followed.
- This will be an open grill contest. Charcoal, wood or gas grills are acceptable—you must bring your own grill.
- No holes or dug pits are permitted.
- No par-boiling or frying in oil is permitted.
- Check-in and set-up time will be between 7:30 am and 9:00am on Saturday, September 10.
- Any questions concerning the BBQ should be directed to the BBQ contest Judges who will make all final decisions. These decisions will be based on best taste, presentation and best side.
- All ribs must be finished for judging between 12:30 and 12:45pm.
