## **MINUTES**

## 1. CALL TO ORDER AND PLEDGE OF ALLEGIANCE

Mayor Phillip Mortensen called the meeting to order and led the Pledge of Allegiance.

3. APPROVAL OF AGENDA - Council Declaration of Conflict of Interest

Mayor Pro Tem Skinner motioned to approve the agenda with the amendment of adding "Councilor Comments" prior to adjournment. Councilor Harmon seconded. 4-0. Motion passed.

#### 6. REGULAR ITEMS

a. Discussion/Possible Action: Fire Station #1 Rebuild

Mayor Mortensen updated the Council about the FY22 NM Fire Protection Grant Council Award of \$400,000 towards rebuilding Fire Station #1. Studio D Architects developed a conceptional design. There is also the option of using the money to tear down the old building and erect a temporary metal one until additional funds are secured.

Mayor Pro Tem Skinner motioned to use the \$400,000 to tear down the old building and build a metal building with three bays. Councilor Atwell seconded. Clerk-Treasurer Bush conducted a roll call vote.

## b. Discussion/Possible Action: Resolution 21-22-111 Budget Adjustment #2 Revision
