- ____ 3. It shall be unlawful for any person to use a dwelling or any other place for the purposes of a dwelling unless the dwelling or place is connected to the City water utility system in compliance with the City Ordinance.
- ____ 4. I understand and agree that the City of Elephant Butte and its agents shall have access to property and equipment located on my premises at all reasonable and necessary times for the purpose of maintaining or operating the water system.
- ____ 5. I understand the City has created Ordinances to govern the water system and I will familiarize myself with these rules and regulations, including the customer complaint process as provided.
- ____ 6. I understand that I will be notified and given a right to address any rate changes the City may propose.
- ____ 7. I understand that it is my responsibility to keep my mailing address current with the City.
- ____ 8. I understand and agree that failure to abide by these Terms and Conditions of this agreement may result in fines, and penalties including but not limited to criminal prosecution.
- ____ 9. **It shall be unlawful for any person to use the water meter shut off for personal use. Warnings or citations will be issued according to the City Ordinance. Each violation can be fined up to \$500.00 and/or 90 days in jail.**
