a. Discussion/Possible Action: Ordinance 221 – Amending Ordinance 52 Water – Approval of Publication for a Public Hearing

City Manager, Janet Porter-Carrejo introduced this ordinance amendment request. Porter-Carrejo stated that this amendment would be to mirror the wastewater ordinance that currently states that all bills will remain the property owner's responsibility.
