Councilor Arnold stated that the city should work towards having succession manuals in place for each department and position in case of a job vacancy. Janet Porter-Carrejo stated that it is a great idea and currently the city is cross training Alex Sullivan at the front desk as well as entering requisitions.

Mayor Mortensen stated he had attended the Governing Board Meeting made several trips to Santa Fe and is looking forward to the Annual Conference in August in Ruidoso.
