### 1. CALL TO ORDER AND PLEDGE OF ALLEGIANCE

#### 5. CONSENT ITEMS

a. Regular Meeting Minutes from February 4, 2025

**Vice-Chair Logan** made a motion to approve the meeting minutes as presented. Commissioner Masce seconded the motion. 3-0. Motion Carried.

### 6. REGULAR ITEMS

a. Discussion/Possible Action: Extension Request on Final Plat - Cielo Entrada

**Janet Porter-Carrejo** introduced the letter that had been submitted requesting an extension for the final plat sumbittal. The request is for a 15-day extension.

**Vice-Chair** Logan made a motion to approve the requested 15-day extension for the final plat sumbittal. Commissioner Masce seconded the motion. 3-0.

b. Discussion/Possible Action: Amendments of Right-of-Way Management Code

Janet Porter-Carrejo and Lindsey Cobleigh introduced this item to the Zoning Commission for review. Porter-Carrejo informed the commission that the city had held a workshop regarding the right-of-way code and met with utility companies and local contractors to receive their input on the needed amendments for this code. Cobleigh stated she had taken the input from that meeting and drafted an amended ordinance for the right-of-way management code. Members of the commission offered a few amendment suggestions for the draft ordinance as well. Line 48, add signage. Line 88, add clarification of expectation of backfill. Line 97, add clarification that the one year begins from the date of city acceptance.

**Vice-Chair Logan** made a motion to approve for recommendation to city council with the discussed amendments. Commissioner Masce seconded the motion. 3-0.

c. Discussion/Possible Action: Zoning Definitions

Lindsey Cobleigh began the discussion on the zoning definition amendments. Cobleigh stated that she had received feedback from Vice-Chair Logan and provided it in the packets for the commission to review. There was a discussion between staff and the commission on the contradictions within the zoning definitions as well as some definitions listed numerous times. Cobleigh and code officer Romero both attested that clarification to the zoning definitions would be a tremendous aid to both of their jobs with the city.

The zoning commission requested that City Clerk, Cobleigh begin drafting an amendment ordinance for the zoning definitions and present it at the next zoning meeting.

#### 7. COMMISSIONER COMMENTS & REPORTS

There was an open discussion between staff and the commission on the possibility of moving from a 3-member zoning board to a 5-member zoning board. Cobleigh suggested that the board meet up with like municipalities during the Spring NMLZO Conference in May and discuss 3-member vs 5-member boards and the possibility of going back to a full Planning and Zoning Commission. Chairman Morris and Vice-Chair Logan are both planning on attending the NMLZO Spring Conference and look forward to the Commissioner based training that will take place at this conference.

Chairman Morris adjourned the meeting.
